BARCC's Core Message

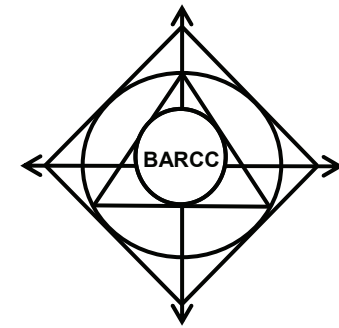
- BARCC believes supporting recovery is a community responsibility.
